Podmienky na absolvovanie predmetu: 30% Active Participation; 30% Presentations; 20% Examinations; 20% Writing Assignments. Course evaluation (%): A – excellent: 100-93%, B – very good: 92-84%, C – good: 83-74%, D – satisfactory: 73-63%, E – sufficient: 62-51%, Fx – fail: 50-0%. Passing the course assumes that student was not absent at more than 4 class sessions. Late arrival is marked as a “tardie”. Three tardies equal one absence. Missing more than 15 minutes of the class is considered an absence.	
Výsledky vzdelávania: In addition to lectures, discussion-based seminars will focus on primary and secondary source readings, and students’ written and oral communication skills will be developed through essays and presentations. Along with increased historical understanding, students will cultivate better critical thinking and analytical skills that can be applied in a range of academic and practical settings.
