Druh, rozsah a metóda vzdelávacích činností: Two weekly meetings of 90 minutes each, amounting 42 hours total. Every week, the first meeting takes the form of a lecture and the second, of a seminar. (full-time form)

Podmienky na absolvovanie predmetu: 20% Active attendance at seminars, participation in debates, preparedness for class; 10% Written class preparation (questions and comments on respective text or a short reflection on the contents of the previous lesson); 20% Quiz; 50% Essay (7-10 pages).

Course evaluation (%): A – excellent: 100-93%, B – very good: 92-84%, C – good: 83-74%, D – satisfactory: 73-63%, E – sufficient: 62-51%, Fx – fail: 50-0%.

Passing the course assumes that student was not absent at more than 4 class sessions. Late arrival is marked as a "tardie". Three tardies equal one absence. Missing more than 15 minutes of the class is considered an absence.

Výsledky vzdelávania: To see the 'big picture' students are encouraged to think critically about the human rights in their entirety. Students will examine, evaluate, and engage critically with different interpretations of political events, trends, phenomena on national and global levels. The course acquaints students with the contemporary issues ranging from torture and arbitrary detention to rights of refugees and access to health. Case studies are being conducted with and by students during the semester. Online meetings with experts and practitioners are organised when feasible. In addition, students will learn to:

- Promote liberal democratic values
- Encourage caring and responsible attitude towards self, others, and the world
- Foster tolerance and empathy, and promote diversity
